Written comments may also be submitted and should be received in the LVHOA Office by noon on Friday May 17th, 2024, in order to be read aloud at the meeting.

LVHOA members have the right to have a copy of the audio recording, the minutes or a summary of the minutes of the meeting provided to the unit's owner upon request, in electronic format at no charge to the unit's owner or, if the association is unable to provide the copy or summary in electronic format, in paper format at a cost not to exceed 25 cents per page for the first 10 pages, and 10 cents per page thereafter.
